SUMMARY OF WORK

1.0 GENERAL

1.1 Scope of Work

- 1.1.1 The general description of work to be performed includes, but is not necessarily limited to, the following items and activities listed. All work required to complete the construction and installation as conceived and depicted or delineated on the drawings, and as described in the specifications shall be included.
- 1.1.2 The work includes connections to existing and new power supplies, and installation of necessary materials and equipment for providing charging stations for new electric material handling equipment (forklifts) that are
- 1.1.3 The CONTRACTOR shall provide all equipment necessary to complete this project and will be responsible for the security of the equipment on the site. Unless specifically noted herein, there will be no SJPC equipment available for the CONTRACTOR to use.

1.2 Continuous Facility Operation

1.2.1 The Terminals will be in continuous service during the work. Normal facility activities may affect construction activities. The CONTRACTOR will coordinate all work activities with the **Engineer Of Record**, the **PROJECT ENGINEER**. The CONTRACTOR will take specific precaution not to have their people, materials, equipment, or construction methods interfere or limit the accessibility of operational personnel to areas of the facility that must be routinely accessed. The CONTRACTOR is to maintain all utilities, conduit, piping, instrumentation, etc. in-service during construction. In particular, any facility or section power outages required by this work must be closely coordinated with the facility, such that timing and duration of the outages have the minimum impact possible on the facilities.

1.3 Location

1.3.1 Access to the Terminals:

Access to the Broadway and Balzano Terminals is granted by means of guarded gateways and requires certain ID as a United States citizen.

Unsupervised access is allowed only be means of a Transport Workers Identification Card (TWIC).

Persons seeking access to SJPC facilities who do not physically possess a TWIC may only enter SJPC facilities with an SJPC approved TWIC escort as a side-by-side companion. Each designated TWIC escort will be allowed to escort a maximum of five individuals at any one time.

The sponsoring employer making the nomination for TWIC escorts shall submit the application at least (7) days prior to assignment as a TWIC escort. Application shall include a full-size color copy of the TWIC of the nominated employee and certification of training as per 33 CFR 105.215. In addition, the sponsoring employer must certify that the nominated TWIC escort is a full-time employee of the company.

In requesting application for TWIC escorts, the sponsoring company assumes all responsibility for each nominated employee to meet the mandated TWIC escorting requirements relating to restricted area access and agrees to assume any liability imposed by competent Federal authorities for failure of such nominated employee to discharge all responsibilities in accordance with all federal law and policy.

1.3.2 All work is located at the Broadway and Balzano Terminals of the South Jersey Port Corporation Facility in Camden, NJ.

1.5 Safety

- 1.5.1 All the work herein specified shall be performed according to applicable OSHA standards, and in accordance with all local, state, and federal regulations. It is to be clearly understood that the CONTRACTOR is solely responsible for the safety of their workers, their SUBCONTRACTORS, and equipment.
- 1.5.2 CONTRACTOR shall submit a Safe Work Plan to **PROJECT ENGINEER** for review and approval at least one (1) week prior to construction kick-off.

1.6 Scheduling

- 1.6.1 The sequence of construction activities, and methods to be employed, shall be subject to the review and approval of the PROJECT ENGINEER to minimize interference with SJPC operations. At the time of award, the CONTRACTOR shall work with SJPC personnel to ensure that schedule for this project will ensure that the project is finished in a reasonable time period while allowing port operations to continue uninterrupted.
- 1.6.2 CONTRACTOR'S bid shall assume working at the facility eight (8) hours per day, five (5) days per week, during standard daylight hours, Monday through Friday.
- 1.6.3 Assume the facility will be in-service for the duration of this work.

1.7 Clean Up

1.7.1 Remove from the site all temporary structures, rubbish, unused materials, etc., and leave the site neat and clean. The CONTRACTOR shall be responsible for proper environmental disposal of all material removed during demolition.

1.8 Construction Sequence

1.8.1 The CONTRACTOR shall submit their proposed schedule for approval.

1.9 Submittals

The CONTRACTOR shall submit all items, and Invoicing, to the **Engineer of Record**, the **PROJECT ENGINEER**, for review and approval prior to each submission, each item shall be checked by the CONTRACTOR for compliance with the contract documents and coordination for compatibly with all other components of the structure. The CONTRACTOR shall stamp and date each submission indicating that they have completed the pre-submission coordination check.

- 1.9.1 Certificates of Compliance, product data, mill certifications and catalog cuts shall be submitted for all material, equipment, etc. used on this project. All warranty information for equipment installed will be submitted.
- 1.9.2 Additional submittals are listed in each technical section.
- 1.9.3 CONTRACTOR shall submit electronic copies of each submittal to the **PROJECT ENGINEER** for review.
- 1.9.4 All submittals shall be reviewed, dated, and stamped as reviewed by the CONTRACTOR.
- 1.9.5 CONTRACTOR shall submit a submittal schedule indicating each submittal with a number and anticipated date of the submittal prior to start of construction. Each submittal shall reference the appropriate technical section number, such as 01, 02, etc.
- 1.9.6 CONTRACTOR shall submit a marked up as-built set of construction drawings to the **PROJECT ENGINEER** at the end of the project.

2.0 EXECUTION

- 2.1 Any damage to existing structures, utilities and property caused during construction and the costs involved with repair of said damage are the full responsibility of the CONTRACTOR. This includes the work of any SUBCONTRACTORS hired by CONTRACTOR to complete the work.
- 2.2 The CONTRACTOR shall check and verify all conditions and dimensions at the site before proceeding with the work including any fabrication and erection. The CONTRACTOR shall report any discrepancies in writing to the engineer for correction prior to beginning any work. The discovery of discrepancies after the work has commenced shall be the responsibility of the CONTRACTOR.

1.0 GENERAL

1.1 Scope of Work

The work under this section includes the furnishing of all labor, equipment, tools, services, and materials necessary for installation of new electric services, panels, foundations, and vehicle chargers. This work shall include, but not be limited to, the work described in the attached scope of work details.

1.2 Salvaged Materials

Excavated material shall be stored on-site at a location designated by the **PROJECT ENGINEER**. Materials and equipment which are unsuitable for reuse, in the opinion of the **PROJECT ENGINEER**, shall become the property of the CONTRACTOR and shall be removed from site and properly disposed of at the CONTRACTOR'S expense. Material to be salvaged will be moved to an area determined by SJPC and retained by owner.

2.0 PRODUCTS

3.0 EXECUTION

3.1 Perform the work without damage to the adjacent areas. If such adjacent areas are damaged, patch, repair or otherwise restore same to its original condition. All existing materials, fixtures, and equipment which are removed but are not indicated or specified for reuse in any of the new work shall become the property of the CONTRACTOR and shall be removed from the site by the CONTRACTOR at their expense. Perform removals in a neat and workmanlike manner to the limits indicated or specified, or to the minimum extent necessary or required for the proper installation of new work.

3.2 Debris

Immediately remove debris from the site, or stockpile neatly within an assigned work area and remove as often as necessary, but not less than at least once a week.

3.3 Protection

Take all necessary precautions to adequately protect personnel and property in the areas of work. Provide approved barriers and warning signs to reroute personnel around areas of dangerous work.

4.0 SCOPE OF WORK DETAILS

Electric Vehicle Charging Stations Project Scope and Details

General requirements

- 1) All work to be done in accordance with NEC and local inspection authority.
- 2) Contractor to supply cut sheets for quoted transformers, panels, and poles.
- 3) All work for PSE&G Transformer to comply with PSE&G standards.

Water Tower Area - Broadway Marine Terminal

1) Provide all conduits, wiring, foundations, and supports as required by PSE&G for 1000KVA pad mount 480/277V transformer with dual 500 MCM cables to each of 2 port distribution panels. Repair any damage to paving, sidewalks, curbs, etc., associated with installation of underground conduits.

DETAILS WILL BE PROVIDED LATER PER PSE&G DESIGN

- 2) Foundations
 - a) 3' by 6' for each 200A charger (2 required)
 - b) 3' by 3' for each 100A charger and conduit support (9 required)
 - c) 3' by 7' for panel (2 Required)
 - d) As required by PSE&G for transformer, CT box and meter enclosure. (DETAILS LATER)
- 3) Build rack for panels and conduit supports.
- 4) Install panels, transformers, and chargers to completion.
- 5) Install conduit and wire to connect all items, wire to be THHN, conduit to be hot dipped galvanized

- a) Transformer to panel: Dual 500MCM copper 4 wire in two 3" C for each. Feed into Panel 1 will come in underground directly from transformer. Feed for panel 2 will come above ground to junction box just past panel 1 and continue aboveground to the panel. TO BE CONFIRMED PER PSE&G DESIGN
- c) Panel to 200A (2 each) charger 3-2/0 & #6 gnd in 2"C
- d) Panel to 100A charger (9 each) 3-#2 with #6 gnd in 1 1/2"C
- 6) Run 277V circuit to Meter house for heaters from Panel 1
- 7) Grounding: Provide ground rod at transformer and each panel, bond all conduit, rods, and rebar to ground system per NEC.

Main Substation Area - Broadway Marine Terminal

- 1) Move office transformer feeder from section 1 to 3, outage must be after hours or weekend, if site cannot permit outage length, then generator must be rented and connected at transformer
 - a) Open trench and if needed pump out any water, supply lighting for work in trench. check existing Yard office sub cable and order terminations. Check spare conduit to cubical #3
 - b) If needed stage generator and transfer overload. Check rotation of 208 before and after connection.
 - c) Shut down cubical #1, mark connections phasing, pull out wire, shutdown cubical #3, pull wire in cubical #3 spare conduit, provide new terminations for cable. Re-energize cubical #3.
 - d) Check rotation of transformer secondary to make sure it's the same. Shut down transformer and transfer off of generator.
- 2) Construct new foundations
 - a) ~ 10' by 10' for transformer

NOTE: For Transformer foundation excavation check possibility of relocating north most conduit for cubical directly into foundation otherwise provide underground conduit to trench.

b) 3' by 3' for each charger and conduit support, 9 places

- c) 3' by 5' for panel
- 3) Build rack for panel and conduit supports
- 4) Install transformer, panel, and chargers.
- 5) Install conduit and wire to connect all items, 480V wire to be THHN, conduit to be hot dipped galvanized
 - a) Transformer to panel dual 4 conductor 500MCM copper plus 1/0 ground in two 3 1/2" C
 - b) Total 9 Panel 70A breaker to 60A charger 3-#6 with #6 gnd in 1"C
- c) Section 1 to Transformer- 5 kv shielded copper EPR insulation 3-1/0 & #2 ground in 3"C provide all stress cone/elbow connections.
- 6) Grounding: 2/0 ground is to be extended from transformer to switchgear ground grid underground. Rebar in transformer foundation is to be grounded and bonded to transformer. A ground rod is to be installed at panel.

Water Tower Area - Balzano Marine Terminal

- 1) Provide all conduits, wiring, foundations, grounding and supports as required by PSE&G for 1000KVA pad mount 480/277V transformer with dual 500 MCM cables to each of 2 port distribution panels. DETAILS LATER
- 2) Foundations
 - a) 3' by 6' for each 200A charger and conduit supports (4 places)
 - b) 3' by 3' for each 100A charger and conduit support (2 places)
 - c) 3' by 3' for portable charger (1 place)
- 3) Build rack for panels and conduit supports.
- 4) Install conduit and wire to connect all items, wire to be THHN, conduit to be hot dipped galvanized
 - a) Transformer to panel: dual 4 conductor 500MCM copper two 3 " C to each panel. conduit is to be installed underground from transformer to each panel
 - b) Panel to 200A (4 each) charger 3-2/0 & #6 gnd in 2"C
 - c) Panel to 100A charger (2 each) 3-#2 with #6 gnd in 1 1/2"C

- e) Panel to 50A plug for charger for yard horse truck 4-#8 with #6 gnd in 1"C, also supply 20 ft SO cord and plug for charger
- 6) Run 277V circuit to Meter house for heaters from Panel 1
- 7) Grounding: Provide ground rod at transformer and each panel, bond all conduit, rods, and rebar to ground system, per NEC.

BID BOND

The Form of Bid Security shall be a BID BOND to accompany the Bid Proposal Package in the amount of 10% of the total bid price not to exceed \$20,000.

PERFORMANCE BOND

Each bid shall also be accompanied by a letter of intent from the Bidder's Bonding Company confirming that, if the Bidder is awarded the Contract, the Bonding Company will furnish the required PERFORMANCE BOND EQUAL TO THE BID PRICE.

Each Surety submitted must be with a company that is rated at least A- or better with AM Best and proof of same must accompany the bid.

The award shall be subject to securing nay necessary permits governing the work.

WARRANTY

Contractor shall provide a warranty covering equipment, material, and workmanship for a minimum of one year, starting from completion and acceptance of the installed components.

EXECUTIVE ORDER NO. 271 COMPLIANCE

Per attached Executive Order No. 271, the contractor of any subcontractors that is party to this contract ("covered contractor(s)") must maintain a policy that requires all covered workers to either provide adequate proof to the covered contractor that they have been fully vaccinated or submit to COVID-19 testing at a minimum one to two times weekly.

- d) The Contractor's insurance carrier (s) shall agree to provide at least thirty (30) days prior written notice to SJPC in the event coverage is canceled or non-renewed and ten (10) days in the event of cancellation for non-payment of premium. In the event of cancellation or non-renewal of coverage(s), it is the Contractor's responsibility to replace coverage to comply with the Contract requirements so there is no lapse of coverage for any time period.
 - In the event the insurance carriers will not issue or endorse their policy(s) to comply with the above it is the responsibility of the Contractor to report any notice of cancellation or non-renewal at least thirty (30) days prior to the effective date of this notice.
- e) Contractor shall provide SJPC with Certificates of Insurance, evidencing the insurance coverages listed below, ten days prior to the start of work and thereafter upon renewal or replacement of each coverage. The Contractor shall not begin any work until SJPC has reviewed and approved the Certificate of Insurance. The required insurance shall not contain any exclusions or endorsements, which are not acceptable to SJPC.

Failure of SJPC to demand such certificate or other evidence of full compliance with these insurance requirements or failure of SJPC to identify a deficiency from evidence that is provided shall not be construed as a waiver of Contractor's obligation to maintain such insurance.

With respect to insurance maintained after final payment in compliance with a requirement below, an additional certificate(s) evidencing such coverage shall be provided to SJPC with final application for payment and thereafter upon renewal or replacement of such insurance until the expiration of the time period for which such insurance must be maintained.

f) SJPC shall be added as ADDITIONAL INSURED on all liability policies (except Workers' Compensation and Professional Liability Policy, where applicable), for ongoing operations and completed operations (using ISO Endorsements CG 2010 and CG 2037, or their equivalents) on a primary noncontributory basis. Coverage to include ongoing and completed operations. Each of the Additional Insured's respective officials, employees, agents and representatives shall also be afforded coverage as an Additional Insured. Coverage should be provided for a period of three years subsequent to the completion of work/final payment.

SJPC reserves the right to require Contractor to name other parties as additional insureds as required by SJPC.

The Contractor shall forward such documents received to his insurance company(ies), as soon as practicable, or as required by their insurance policy(ies).

In any and all claims against the South Jersey Port Corporation or any of their respective officials, employees, agents and representatives, by an employee of the selected services provider, Contractor, Subcontractor, or any Sub-subcontractor, or anyone directly or indirectly employed by any of them, or anyone for whose acts any of them may be liable, the indemnification obligation shall not be limited in any way by any limitation on the amount or type of damages, compensation or benefits payable by or for any Contractor, Subcontractor or any Sub-subcontractor under Workmen's Compensation Acts, Disability Benefits Acts, or other Employee.

These Indemnification provisions shall survive the termination of this Contract.

EXAMINATION AND RESPONSIBILITY

Bidders should become thoroughly aware of the conditions under which the work will be performed. A Pre-Bid Meeting will be held to orient potential bidders of the project site. Attendance of the Pre-Bid Meeting strongly recommended.

Questions raised by Bidders shall be in writing and will only be officially answered by the issuance of Addenda to all bidders. Only such Addenda will be considered part of the Contract Documents.

Bidders must carefully examine, for themselves, the plans, detailed drawings, estimated quantities and the location of the proposed work, if applicable. They shall exercise their own judgement as to the full scope and nature of the work, the difficulties to be encountered and the accuracy of estimated quantities, when given. Each Bidder will be held fully responsible for having complied with, and thoroughly understood the Contract Documents prior to submitting their bid; and shall not, at any time, thereafter complain of such estimates, nor assert that there was any misunderstanding in regard to the nature or amount of work to be done.

QUALIFICATIONS OF BIDDERS

The Owner may make such investigation, as is deemed necessary, to determine the ability of the Bidder to perform the work; and the Bidder shall furnish to the Owner all such information and data for this purpose as the Owner may request. The Owner reserves the right to reject any bid if the evidence submitted by, or the investigation of such Bidder fails to satisfy the Owner that such Bidder is properly qualified to carry out the obligations of the Contract, and to complete the work therein contemplated. Conditional bids will not be accepted. See also paragraphs in these documents relating to subcontract work.

SUBMISSION OF BIDS

Bids must be submitted at the specified time due in sealed envelopes bearing the name and address of the Bidder on the outside, and also bearing, on the outside, reference to work bid upon. Any bid may be submitted or withdrawn prior to the scheduled time for the opening of bids, or the authorized postponement thereof. Any bid received after the time and date specified in the Advertisement for Bids or Addenda will not be considered. No Bid may be withdrawn within sixty (60) days after the actual date of the opening thereof.

REJECTION OF BIDS

The Owner reserves the right to reject any or all Bids received. The Owner also reserves the right to receive any and all Bids in whatsoever form they may be, and to waive any informalities in said Bids; or to

award the work to whichever Bidder or Bidders it may be considered advantageous so to do, regardless of Bid prices.

SUBCONTRACT WORK

The Bidder shall submit with their Bid, a description of Contract Work they will not be performing with their organization, if any.

OBLIGATIONS OF BIDDERS

At the time of the opening of Bids, each Bidder will be presumed to have inspected the site, and to have read, and to be thoroughly familiar with the Plans and Contract Documents, including all Addenda. The failure or omission of any Bidder to receive or examine any form, instrument, or document, shall in no way relieve the Bidder from any obligations in respect to their bid.

CONDITION OF WORK

Each Bidder must inform themselves fully of the conditions relative to the construction under which the work will be performed. Failure to do so will not relieve a successful Bidder of their obligation to furnish all material and labor necessary to carry out the provisions of the Contract Documents, and to complete the contemplated work for the construction set forth in their Bid.

CONTRACTORS SCHEDULE

The Contractor shall provide to the SJPC and Engineer of Record for the SJPC a schedule of planned submittals and their proposed construction schedule within two weeks after award of an RFP proposal. The schedule of anticipated submittals for the work to be performed shall include a listing of shop drawings, catalogue cuts, material data sheets etc. together with forecasted dates for planned submission to the Engineer of Record. The construction critical path method (CPM) schedule shall include milestone activities with durations and completion dates necessary for the performance of all contract construction work. The Contractor is requested to provide monthly updates to the aforementioned schedule for the duration of construction.

LIQUIDATED DAMAGES

In case the Contractor fails to complete the work contracted for, in a manner satisfactory to and acceptable to the Owner, within the stipulated time limit, then the Contractor shall and will pay to the Owner for each and every day they, the Contractor, shall be in default, the sum of Two Thousand Dollars (\$2,000.00) or the sum equal to 1/20 of one percent (1%) of the total consideration provided for under the contract, whichever sum if the greater, which sum per day is agreed upon, fixed and determined by the parties hereto to be liquidated damages, not a penalty.

The Owner shall recover said damages by deducting the amount thereof out of any monies which may be due or become due to Contractor, or by an action of law against the Contractor or their surety, or by either or both of these methods.

In case the Contractor shall be delayed due to the failure on the part of the Owner to furnish anything on its part to be furnished, or of any other cause beyond the control of the Contractor, they shall be entitled to such an extension of time for the delivery of equipment, materials, work and supplies as is the judgement of the Owner shall be fair and just.

EVALUATION OF RESPONSES

Method

The proposal review team will consist of individuals from the SJPC who will independently analyze each proposal. The evaluation team will analyze how the Respondents qualifications, experience, professional content and proposed methodology meet the SJPC's needs. Proposals should be prepared simply and economically, providing straightforward, concise description of the Vendor's capabilities to satisfy the requirements of this request.

Criteria

It is the policy of the SJPC that the selection of vendors shall be on the basis of demonstrated competence and on the professional qualifications necessary for the satisfactory performance of the services required. The SJPC will put each proposal submitted through a process of evaluation to determine responsiveness to all administrative and technical requirements of the RFB. Proposals will be evaluated primarily on cost/cost effectiveness, but the respondent's qualifications, experience, project approach, and methodology may also be considered when evaluating the responsibility of a bid.

The evaluation criteria are intended to be used to make a recommendation to the SJPC Board of Directors, who will award the contract, but who are not bound to use the criteria or to award to Respondent on the basis of the recommendation. WHEREAS, on March 9, 2020, I issued Executive Order No. 103, declaring the existence of a Public Health Emergency, pursuant to the Emergency Health Powers Act ("EHPA"), N.J.S.A. 26:13-1 et seq., and a State of Emergency, pursuant to the New Jersey Civilian Defense and Disaster Control Act ("Disaster Control Act"), N.J.S.A. App A:9-33 et seq., in the State of New Jersey for Coronavirus disease 2019 ("COVID-19"); and

WHEREAS, through Executive Order Nos. 119, 138, 151, 162, 171, 180, 186, 191, 200, 210, 215, 222, 231, 235, and 240, issued on April 7, 2020, May 6, 2020, June 4, 2020, July 2, 2020, August 1, 2020, August 27, 2020, September 25, 2020, October 24, 2020, November 22, 2020, December 21, 2020, January 19, 2021, February 17, 2021, March 17, 2021, April 15, 2021, and May 14, 2021, respectively, the facts and circumstances of which are adopted by reference herein, I declared that the COVID-19 Public Health Emergency continued to exist and declared that all Executive Orders and Administrative Orders adopted in whole or in part in response to the COVID-19 Public Health Emergency remained in full force and effect; and

WHEREAS, in accordance with N.J.S.A. App. A:9-34 and -51, I reserve the right to utilize and employ all available resources of State government to protect against the emergency created by COVID-19; and

WHEREAS, as COVID-19 continued to spread across New Jersey, I have issued a series of Executive Orders pursuant to my authority under the EHPA and the Disaster Control Act, to protect the public health, safety, and welfare against the emergency created by COVID-19, including Executive Order Nos. 104-133, Nos. 135-138, Nos. 140-166, Nos. 168-173, No. 175, Nos. 177-181, No. 183, Nos. 186-187, Nos. 189- 198, No. 200, Nos. 203-204, No. 207, and

Nos. 210-211 (2020) and Nos. 214-216, Nos. 219-220, Nos. 222-223, No. 225, Nos. 228-235, Nos. 237-244, No. 246, No. 249, Nos. 251-253, Nos. 263-264, and Nos. 266-267 (2021), the facts and circumstances of which are all adopted by reference herein; and

WHEREAS, on June 4, 2021, I signed Assembly Bill No. 5820 into law as P.L.2021, c.103 and issued Executive Order No. 244, which terminated the Public Health Emergency declared in Executive Order No. 103 (2020) but maintained the State of Emergency declared in that same Order; and

WHEREAS, P.L.2021, c.103 provided that following the termination of the Public Health Emergency declared in Executive Order No. 103 (2020), the Governor, Department of Health ("DOH") Commissioner (the "Commissioner"), and the head of any other State agency may continue to issue orders related to implementation of

recommendations of the Centers for Disease Control and Prevention ("CDC") to prevent or limit the transmission of COVID-19 and related to vaccine distribution, administration, and management, COVID-19 testing, and data collection; and

WHEREAS, parties that contract with the State government provide essential services to the public and interact with the public on a regular basis, and because of the nature of their work, a significant portion of their workers are not able to work remotely; and

WHEREAS, ensuring the safety of the government workforce during this overall escalation in COVID-19 cases, hospitalizations, and deaths resulting from the B.1.617.2 ("Delta") variant is essential for continued operation and service to the public, and it is fitting and proper to require additional protections to the State workforce and public by requiring contractors to provide their vaccination or testing status as a

condition of entry onto State property and into State facilities, including property and facilities leased by a contractor; and

WHEREAS, the CDC has reported that new variants of COVID-19 have been identified in the United States, and that certain variants, particularly the Delta variant, are more transmissible than previous strains; and

WHEREAS, the State has experienced significant overall upticks in critical COVID-19 metrics since July of this year, including COVID-19 positive cases, the rate of transmission, spot positivity, and new hospitalizations, that warrant additional precautions in certain settings, especially those with a substantial number of unvaccinated individuals; and

WHEREAS, while over 5.7 million people in the State have been fully vaccinated against COVID-19, additional steps are necessary to ensure continued vaccinations of individuals in certain settings of concern to protect against the spread of COVID-19; and

WHEREAS, on July 6, 2021, the U.S. Department of Justice's Office of Legal Counsel issued an opinion concluding that Section 564 of the Food, Drug, and Cosmetic Act, 21 U.S.C. § 360bbb-3 does not prohibit public or private entities from imposing vaccination requirements while vaccinations are only available pursuant to Emergency Use Authorization ("EUA"); and

WHEREAS, ensuring that parties that contract with the State government provide adequate COVID-19 safeguards to their workers performing on or in connection with a State government contract will decrease worker absence, reduce labor costs, and improve the efficiency of contractors and subcontractors at sites where they are performing work for the State; and

WHEREAS, the CDC has emphasized that COVID-19 vaccines are effective, in that they can prevent individuals from getting and spreading the virus, and can prevent severe illness in individuals who do contract COVID-19; and

WHEREAS, this Order is related to vaccination management, COVID-19 testing, data collection, and the implementation of CDC recommendations, and is thus authorized under P.L.2021, c.103; NOW, THEREFORE, I, PHILIP D. MURPHY, Governor of the State of

New Jersey, by virtue of the authority vested in me by the Constitution and by the Statutes of this State, do hereby ORDER and DIRECT:

- 1. Each executive department and agency, including an independent authority, shall, to the extent permitted by law, ensure that contracts or agreements entered into by the executive department or agency include a clause that the contractor or any subcontractors, at any tier, that is party to the contract ("covered contractor(s)") must maintain a policy that requires all covered workers to either provide adequate proof to the covered contractor that they have been fully vaccinated or submit to COVID-19 testing at minimum one to two times weekly. This clause shall also be required to be incorporated into lower-tier subcontracts. Any covered worker subject to a policy maintained pursuant to this paragraph that has not provided adequate proof that the covered worker is fully vaccinated must submit to a minimum of weekly or twice weekly testing on an ongoing basis until fully vaccinated.
- 2. This Order shall apply to any new contract, new solicitation for a contract, extension or renewal of an existing contract, and exercise of an option on an existing contract, if it is a contract for services, construction, including demolition

remediation, removal of hazardous substances, alteration, custom fabrication, repair work, or maintenance work, or a leasehold interest in real property through which covered workers have access to State property, and the cost or contract price thereof is to be paid, in whole or in part, with or out of executive department or agency funds. This Order shall not apply to financial assistance, including but not limited to grants, bonds, loans, or tax credits; contracts or subcontracts whose value is less than the State bid advertising threshold under N.J.S.A. 52:34-7; employees who perform work outside of the State; or contracts solely for the provision of goods.

- 3. Covered workers may demonstrate proof of full vaccination status by presenting the following documents to the covered contractor if they list COVID-19 vaccines currently authorized for EUA in the United States and/or the World Health Organization ("WHO"), along with an administration date for each dose:
 - a. The CDC COVID-19 Vaccination Card issued to the vaccine recipient by the vaccination site, or an electronic or physical copy of the same;

- b. Official record from the New Jersey
 Immunization Information S y s t e m (NJIIS) or
 other State immunization registry;
- c. A record from a health care
 provider's portal/medical record system on
 official letterhead signed by a licensed
 physician, nurse practitioner, physician's
 assistant, registered nurse or pharmacist;
- d. A military immunization or health record from the United States Armed Forces; or
- e. Docket mobile phone application record or any state specific application that produces a digital health record.

Covered contractors collecting vaccination information from covered workers must comport with all federal and State laws, including but not limited to the Americans with Disabilities Act, that regulate the collection and storage of that information.

4. To satisfy the testing requirement, a covered worker must undergo screening testing at minimum one to two times weekly. Where a covered contractor requires an unvaccinated covered worker to submit proof of a COVID-19 test, the worker may choose either antigen or molecular tests that have EUA by the U.S. Food and Drug Administration ("FDA") or are operating per the Laboratory Developed Test

requirements by the U.S. Centers for Medicare and Medicaid Services. Where a covered contractor provides the unvaccinated covered worker with on-site access to COVID-19 tests, the covered contractor may similarly elect to administer or provide access to either an antigen or molecular test. If the covered worker is not working on-site during a week where testing would otherwise be required, the covered contractor's policy need not require the worker to submit to testing for that week. This requirement shall not supplant any requirement imposed by the covered contractor regarding diagnostic testing of symptomatic workers or screening testing of vaccinated workers.

- 5. Covered contractors must have a policy for tracking test results from testing required by this Order and must report results to local public health departments.
 - 6. An executive department or agency shall require bidders

for contracts subject to this Order to certify at the time of bid or proposal or prior to executing a contract that the bidder, if

awarded a contract, shall comply with this Order by having the policies and practices required by this Order in place, and

shall collect all data necessary for compliance with this Order. Covered contractors shall certify, at the time of submission of an invoice, that they have complied with this Order during the period of time covered by the invoice.

7. For purposes of this Order, "covered worker" means any full-time or part-time worker for a covered contractor working on or in connection with a contract with an executive department or agency that requires such worker to enter, work at, or provide services in any place, site, installation, building, room, or facility in which any executive department or agency conducts official business or is within an executive department or agency's jurisdiction, custody, or control, or that relates to offering services for State employees, their dependents, or the general public.

8.

For purposes of this Order, a covered worker shall be considered "fully vaccinated" for COVID-19 two weeks or more after they have received the second dose in a two-dose series or two weeks or more after they have received a single-dose vaccine. Individuals will only be considered fully vaccinated where they have received a COVID-19 vaccine that is currently authorized for emergency use by the FDA or the WHO, or that are approved for use by the same. Workers who are not fully

vaccinated, or for whom vaccination status is unknown or who have not provided sufficient proof of documentation, shall be considered unvaccinated for purposes of this Order.

- 9. Nothing in this Order shall prevent a covered contractor from instituting a vaccination or testing policy that includes additional or stricter requirements, so long as such policy8 comports with the minimum requirements of this Order. A covered contractor may also maintain a policy that requires more frequent testing of covered workers.
- 10. The Commissioner is hereby authorized to issue a

directive supplementing the requirements outlined in this

Order, which may include, but not be limited to, any

requirements for reporting vaccination and testing data to the

DOH. Actions taken by the Commissioner pursuant to this Order

shall not be subject to the requirements of the Administrative

Procedure Act, N.J.S.A.

52:14B-1 et seq.

11. The State Director of Emergency Management, who is the Superintendent of State Police, shall have the discretion to make additions, amendments, clarifications, exceptions, and exclusions to the terms of this Order.

- 12. It shall be the duty of every person or entity in this State or doing business in this State and of the members of the governing body and every official, employee, or agent of every political subdivision in this State and of each member of all other governmental bodies, agencies, and authorities in this State of any nature whatsoever, to cooperate fully in all matters concerning this Order, and to cooperate fully with any Administrative Orders issued pursuant to this Order.
- 13. No municipality, county, or any other agency or political subdivision of this State shall enact or enforce any order, rule, regulation, ordinance, or resolution which will or might in any way conflict with any of the provisions of this Order, or which will or might in any way interfere with or impede its achievement.
- 14. Penalties for violations of this Order may be imposed under, among other statutes, $\underline{\text{N.J.S.A.}}$ App. A:9-49 and -50.

15. This Order shall take effect immediately and shall remain in effect until revoked or modified by the Governor.

South Jersey Port Corporation Application for TWIC Escort Sponsorship

In accordance with 33 CFR 101.514, all persons requiring unescorted access to restricted South Jersey Port Corporation (SJPC or "Port Corporation") facilities must possess a Transportation Worker Identification Credential (TWIC) before such access is granted. Persons seeking access to SJPC facilities who do not physcially possess a TWIC may only enter SJPC facilities with an SJPC approved TWIC escort as a side-by-side companion. Each designated TWIC escort will be allowed to escort a maximum of five (5) individuals at any one time.

The sponsoring employer making the nomination for TWIC escorts shall submit the application at least seven (7) days prior to assignment as a TWIC escort. Application shall include a full-size color copy of the TWIC of the nominated employee and certification of training as per 33 CFR 105.215. In addition, the sponsoring employer must certify that the nominated TWIC escort is a full-time employee of the company.

In requesting application for TWIC escorts, the sponsoring company assumes all responsibility for each nominated employee to meet the mandated TWIC escorting requirements relating to restricted area access and agrees to assume any liability imposed by competent Federal authorities for failure of such nominated employee to discharge all responsibilities in accordance with all federal law and policy.

- 2. Conviction of an approved TWIC escort of any offense for which he or she would have initially been denied approval in accordance with the policies of the Port Corporation.
- 3. Failure to present a TWIC upon request, loss of TWIC privileges or an expired TWIC,
- 4. An employer no longer meets the criteria under which their eligibility was initally established or an approved TWIC escort leaves the employment of the company for which escorting privileges were approved.
