Staff is requesting Board approval to retain the law firm of Brown & Connery, LLP, as Special Counsel in Holcim (US), Inc., v. South Jersey Port Corporation.

BACKGROUND

Holcim, Inc., a former tenant that assigned their lease to Lehigh Cement in 2015, has brought a lawsuit against SJPC to have the Port assume environmental remediation responsibilities required by NJDEP under the Industrial Site Recovery Act (ISRA).
