Extend Wi-Fi Cabling at Broadway Terminal Change Order No. 1
New Jersey Business Systems

A contract for installation of a Port Security Camera System at the Balzano and Broadway Terminals was awarded to New Jersey Business Systems from Robbinsville, NJ, in April 2022 by SJPC Board Resolution Number 2022-03-0035 in the amount of \$175,124.00.

The contract is for system design and installation of a wireless network serving security camera equipment provided from another vendor.

In April 2022 the SJPC awarded a contract to ePortation for a Terminal Operating System by SJPC Board Resolution Number 2022-04-0055. The Terminal Operating System is a cloud-based software system which primarily tracks cargo. The Terminal Operating System requires WiFi service in the cargo warehouses in order to serve handheld devices and bar code readers.

Because the warehouses at Broadway do not currently contain WiFi capability, SJPC staff requested a proposal from New Jersey Business Solutions to extend the Wi-Fi and networking equipment from the security camera system to support the ePortation system needs.

Their proposal has been reviewed by SJPC staff who recommend Board Approval of Change Order Number 1 for New Jersey Business Systems in the amount of \$37,958.86, bringing their total contract amount to \$213,082.86.

#### 2 - RESOLUTION #2022-12-0134

Replacement of Security Perimeter Protection at Balzano Terminal Change Order No. 3 Fox Fence Enterprises, Inc.

Replacement of the Security Perimeter Protection at Balzano Terminal was awarded to Fox Fence Enterprises, Inc., Clifton, NJ, in January 2022 by SJPC Resolution Number 2022-01-0005 in the amount of \$256,259.

Two previous change orders were approved to add two new gates. Construction of the project is now approximately 95% complete.

A newly installed section of fence and gate post were recently damaged by others working at the terminal. In order to make repairs, the contractor needs to replace the top and bottom fence rail, the fence fabric and barb wire, and reset the gate post in concrete before placing the new double swing gate.

The cost incurred to repair the damaged fence and gate will be offset by a credit under the other contractor's contract since the fence was damaged by their construction equipment.

Staff requested a proposal from Fox Fence to replace the damaged fence and post. The cost proposed for these repairs is reasonable, and therefore staff requests Board Approval of Change Order Number 3 in the amount of \$4,890, bringing the total contract amount to \$280,189.

# DEMOLITION OF THE BUILDING AT 551 SOUTH SECOND STREET CHANGE ORDER NO. 2 PS&S ENGINEERS

The design services for the demolition of the former Goldstein Building at 551 South Second Street was awarded to Paulus, Sokolowski & Sartor, LLC (PS&S) by Board Resolution 2021-10-0095.

During the demolition of the building, an underground storage tank (UST) was discovered on the site. The tank was removed and legally disposed of by the contractor.

In order to address the NJDEP's mandated requirements and obtain an Unrestricted Use No Further Action Determination from the NJDEP, an amendment was made to the PS&S contract for additional environmental services in June, 2022 by Board Resolution 2022-06-0063.

PS&S performed soil probes and lab testing to delineate the extent of contamination. The test results revealed that the extent of contamination was larger than anticipated, necessitating a second day of field work and additional laboratory testing.

PS&S has prepared the soil remediation plan and permit applications and will oversee the soil removal and clean backfill work to be performed by an outside contractor. Disposal will be contracted with a licensed disposal contractor.

Staff are recommending to the Board the approval of Change Order Number 2 to PS&S in the amount of \$9,800 for the additional environmental services required to complete the contaminated soil removal in accordance with the NJDEP regulations.

#### 4 - RESOLUTION #2022-12-0136

Berth 4 Improvements at Balzano Marine Terminal Change Order No. 4 R.E. Pierson Construction Company

The contract for Berth 4 Improvements at the Balzano Terminal was awarded to the low bidder, R.E. Pierson Construction Company, Woodstown, NJ, in January 2022 by SJPC Resolution Number 2022-01-0006 in the amount of \$1,623,405.00.

The scope of work included subgrade strengthening with drilled shafts filled with concrete (referred to as inclusions), remediation of various drainage catch basins and pipe replacements, the installation of geogrid fabrics under compacted backfill materials, a large concrete slab, and bituminous asphalt paving. The design engineer was S.T. Hudson Engineers of Cherry Hill, NJ.

At the July 12, 2022 SJPC Board meeting, three change orders were approved to the contract by Resolution 2022-07-0072, in the net amount of \$75,574.21, bringing the total contract amount to \$1,698,929.71.

As construction progressed from that time, unforeseen underground conditions were discovered which required additional work including demolition of obstructions, drainage structure repairs, disposal of regulated materials, repairs to the water quality chamber, and others as detailed on the attached exhibits. In addition, there are offsetting credits

for unused sink hole costs, and for the reduction of milling and surface course asphalt quantities not used within the work zone. These credits have been applied, which would have resulted in a net credit for this change order.

However, the most significant line item was the addition of repairs to the outer berth paving which was damaged by the heavy trucks from the scrap loading operation during the construction. These additional costs result in a net change order in the amount of \$158.837.44. This work is needed in order to use Berth 4 for other cargoes.

SJPC staff requests Board Approval of Change Order Number 4 in the net amount of \$158,837.44, bringing the total contract amount from \$1,698,929.71 to \$1,857,767.15.

#### TREASURER'S REPORT

For the month of October 2022, the SJPC generated net income before non-operating interest expense and depreciation and amortization in the amount of \$84,824 which is over budget by \$14,644 for the month. Our (year-to-date) YTD net income as of October 31st is \$1,810,801 which is over budget by \$1,109,009.

Please note that we recognized \$120,522 into deferred revenue from income in October. Our deferred revenue balance has decreased to \$429,609. Fuel expenses continue to be high at \$431,734 YTD, compared to \$243,187 YTD last year, which is an increase of \$188,547. Despite these increasing expenses, we continue to maintain a positive position.

#### **COUNSEL'S REPORT**

The Counsel's Report will be discussed in closed session.

#### **EXECUTIVE DIRECTORS REPORT**

Total cargo tonnage in October was 217,8769 s/tons: a 11% decrease over October 2021. YTD tonnage through October totaled 2,692,445 s/tons; representing a 26% decrease compared to the same period in 2021. Camden Steel imports in October 2022 showed a 53.6.7% increase over October 2021 and a YTD increase of 12.5% compared to 2021. There was no plywood activity in October 2022 or 2021. October YTD plywood tonnage was 69,663 tons which is 61.4% behind YTD 2021

There was no cocoa bean activity in October 2022. YTD cocoa bean imports totaled 38,376 tons which is a 46.2% decrease versus YTD 2021.

Bulk activity for October was 191,727 s/tons; a 53.5% increase from October 2021. YTD bulk reached 1,575,419 s/tons; a 4.2% decrease versus YTD 2021.

Exports of recycled metals in October was 73,670 s/tons; a 210% decrease compared to October 2021. YTD recycled metals decreased 0.7% compared to 2021. October cement increased 6% YTD. Grancem increased 27% for October 2022 with a 13.8% increase YTD. Sand volumes increased 53.7% YTD vs 2021. There was no Gypsum activity in 2022 YTD compared to 57,873 s/tons YTD 2021.

SJPC handled 21 ships in October 2022 compared to 15 in October 2021. YTD the port handled 210 ships, compared to 182 in October 2021 YTD. October 2022 YTD ship days were 714, compared to 790 in 2021.

The Executive Director also updated the Board on the below topics as well:

#### Paulsboro MT / EEW

EEW is close to completing the Paint and Blast Building and has installed welding equipment in the Circ Weld Building and continues to test the equipment.

The GCIA has been preparing the first upland storage area in anticipation of the first vessel carrying monopile segments which is scheduled to arrive on December 22 with 9 monopile sections which will be assembled at Paulsboro Plant

We continue to discuss funding and next steps with EEW and the GCIA.

### Clipper 30th Anniversary

Brendan Dugan and I attended Clipper Lines 30<sup>th</sup> anniversary dinner on November 10<sup>th</sup> in Antwerp Belgium. We presented Clipper with a plaque commemorating Clipper's anniversary and long-term relationship with SJPC.

We were also able to meet other European based customers, including major SJPC customers such as Arcelor Mittal, Thyssen Krupp, and Tata, who also attended the dinner.

#### **TATA Steel Mill Tour**

On November 8<sup>th</sup>, Brendan Dugan, Andy Sentyz from DRS and I met with representatives from TATA Steel and toured TATA's steel mill in IJmuiden Netherlands. Our tour included visiting the steel mill, vessel loading berths, barge loading warehouse and TATA's automated warehouse which loads truck and rail cars via an automated overhead crane. Overall, we had a good tour and discussion with TATA's European staff.

#### **Customer Meetings Amsterdam and Antwerp**

During our visit to Amsterdam, we met with several representatives from Spliethoff Lines to discuss possible future vessel calls from their ships at the Port of Camden. Spliethoff currently operates a seasonal container service into the Great Lakes and is looking for East Coast ports that could accommodate their business when the Great Lakes are closed. We also discussed the possible use of our terminals to support Offshore Wind projects. We will continue to maintain a dialogue with Spliethoff's representatives to discuss the winter season container service opportunity.

We also met with Conti Lines in Antwerp to discuss the use of the Port of Camden. Conti is currently scheduled to bring a shipment of Cocoa to Pier 5 later this year. We will continue to follow up with Conti to explore future business opportunities.

#### **Wind Port Tour**

On November 3<sup>rd</sup>, we met with representatives from NJEDA and were provided with a tour of NJ Windport. EDA is making good progress constructing two berths and preparing the upland marshalling area. They are in active discussions with manufacturers to construct buildings on the site and have plans to construct two additional berths on an adjacent parcel that they recently acquired.

#### **Open House**

We will be holding an open house at our new offices on December 13, 2022 and have invited our Camden based tenants and customers along with some civic and elected officials over to visit our new offices.

We have also invited Director Roberts to participate.

RESOLUTION 2022-12-0138: APPROVAL TO AWARD A CONTRACT FOR THE SERVICES OF A LICENSED SITE REMEDIATION PROFESSIONAL ON AN AS-NEEDED BASIS

#### **REQUEST**

Staff is requesting Board Approval to award a contract to GEI Consultants of Mt. Laurel, New Jersey, to provide Licensed Site Remediation Professional (LRSP) services for all SJPC owned properties on an as-needed basis.

#### BACKGROUND

Pursuant to the Board's authorization in Resolution 2022-07-0075, an RFP was issued to the SJPC list of pre-qualified engineering firms, soliciting the services of a licensed site remediation professional (LRSP) on properties of the South Jersey Port Corporation on an as-needed, task order basis. The contract term is for one year with two one-year renewal options at the discretion of the SJPC. The contract amount is not-to-exceed \$50,000 per year.

An RFP was prepared and distributed to our list of prequalified civil engineering firms. The following seven prequalified civil engineering firms submitted proposals on Wednesday, November 7, 2022.

- 1. New World Matrix
- 2. Pennoni
- 3. T & M Associates
- 4. GEI Consultants, Inc
- 5. French & Parrello Associates
- 6. PS&S
- 7. Mid Atlantic Engineering, LLC

The proposals were reviewed by a selection committee of SJPC staff, and ranked based on LSRP qualifications, firm experience, and proposed hourly rates. The most qualified firm was then interviewed by SJPC staff. It was determined that the proposal submitted by GEI Consultants of Mt. Laurel, NJ was the best value and met all requirements of the RFP. General Counsel review indicated that the bid proposal is in proper legal form.

RESOLUTION 2022-12-0139: REQUEST APPROVAL TO ISSUE AN RFP FOR DESIGN SERVICES TO RESTORE POWER TO ON-DOCK RECEPTACLES FOR RAIL MOUNTED CRANES AT BALZANO MARINE TERMINAL:

#### REQUEST

Staff are requesting Board approval to issue an RFP to the list of prequalified civil engineering firms to perform design services to restore power to on dock powered receptacles for the rail mounted cranes at the Balzano Marine Terminal in Camden, NJ.

#### **BACKGROUND**

The two rail mounted diesel cranes at the Balzano Marine Terminal require service electric power to operate the tower obstruction lights, the HVAC equipment in the crane house, and to operate the on-board computers while the crane is not in use. Currently only seven of the eighteen shore power locations are functional, and they do not provide power at all four crane docking locations, requiring the crane to be returned to the far ends of the terminal after each use.

At their August meeting, by Resolution 2022-08-0090, SJPC Board authorized Reading Crane to evaluate the existing conditions in order to determine the exact locations of conduits, pull boxes, and manholes running from the panels to the power centers, determine their condition for reuse, and provide a detailed report outlining the configurations of the existing circuits, their condition, the work required to make them functional again, and the estimated costs.

On November 2, Reading Crane presented their detailed Assessment Summary and Repair Drawing to SJPC staff, with findings, recommendations, and a cost estimate.

The recommended plan is to restore service to at all four crane parking locations by energizing three damaged stations, providing for a total of ten functional locations. Crane power plugs, on-dock receptacle boxes, and protective bollards will also be replaced. The unused locations will be demolished and safe-ed off.

The estimated construction cost for the work is \$225,000. Because this exceeds the SJPC bidding threshold, a bid package of plans and specifications will need to be prepared and publicly advertised for bids.

# RESOLUTION 2022-12-0141: RECONSTRUCTION OF THE RAIL TRACK AT THE BALZANO TERMINAL, CONTRACT AMENDMENT FOR URBAN ENGINEERS

#### REQUEST

Urban Engineers is being requested to revise the contract drawings in preparation for rebidding of the Rail Reconstruction Project at the Balzano Terminal, Camden, NJ.

SJPC Staff is requesting Board approval for an amendment to the Urban Engineers contract to address this increased scope of work.

#### **BACKGROUND**

Urban Engineers was awarded a contract for design services to rehabilitate the rail track, the Shed 1 loading platform, and other miscellaneous rail repairs at the Balzano Terminal at the December 2020 board meeting by Board Resolution 2020-12-0110 in the amount of \$249,000. The second low-cost proposal for these design services was \$374,950. This project is funded by a NJDOT Rail Freight Assistance Program grant from 2020.

Contract documents were prepared, and the construction contract was publicly advertised for bids. All bids received were in excess of \$10 million, exceeding the project budget which is based on the grant amount of \$6,010,650 being funded by the NDOT Rail Freight Federal Assistance Program. In order to proceed and utilize the grant funds, the project requires rescoping to reduce construction costs, followed by rebidding.

Urban's additional services on this project included the preparation of add / alternate drawings for a new rail spur, additional design efforts to address relocating fence rail gates clearances in support of an ongoing security fence project, revisions to rail track and civil/site work, and remobilization of their survey crew due to cargo covering manholes. Going forward, their additional services include revisions of the drawings to reflect a reduced scope of work, revised quantities takeoffs for the bid form and cost estimating, as well as additional services during the next bid period to support the SJPC in the evaluation of bids received. All of the additional scope is as requested by SJPC.

A motion was made to approve Resolution 2022-12-0141 amend Urban Engineers' contract in the amount of \$55,500 to address additional services as required for the Rail Reconstruction Project at the Balzano Terminal. The total engineering fees would be adjusted from \$249,000 to \$304,500.

RESOLUTION 2022-12-0148: APPROVAL TO EXECUTE SECOND
AMENDMENT TO BROADWAY PIER 5 LEASE BETWEEN SOUTH JERSEY
PORT CORPORATION AND CAMDEN WATERFRONT DEVELOPMENT

#### REOUEST

Staff requests Board approval to execute the 2<sup>nd</sup> Amendment to the Broadway Pier 5 lease between South Jersey Port Corporation (SJPC) and Camden Waterfront Development (CWD)

#### BACKGROUND

As consideration for SJPC providing an upgraded refrigeration system at the Broadway Pier 5 premises and in anticipation of creating approximately 200 jobs, the lease amendment contains the following key provisions:

SJPC to provide up to \$8 million to upgrade the refrigeration system on the premises,
 CWD will be responsible for procurement, installation, maintenance, repair of same, and for any cost overruns of procurement and installation

- Base rent of \$945,526 per year to remain in effect through current lease term expiring January 31, 2025, and subject to granting of any lease extension(s), will increase annually thereafter by CPI-U
- O Up to three 5-year lease extension options will be granted to CWD, providing CWD makes minimum capital investments of \$3 million, with a minimum of \$1million prior to November 30, 2024, a minimum of \$1million prior to November 30, 2029, and a minimum of \$1million prior to November 30, 2034. CWD shall provide SJPC with an accounting, in a form acceptable to the SJPC, of all capital investments; and the accounting and type of the said investments shall be subject to review and approval by the SJPC, prior to the grant of each extension; which said grants shall not be unreasonably withheld. Capital Investments shall be defined for purposes of this section to be the expenditure of money to purchase fixed physical assets exclusively for the Broadway Pier 5 premises, but not the newly added Air Products site, including, but not limited to, fixtures, machines, buildings, and such other tangible assets. Capital investments however for purpose of this definition shall not include money expended by CWD for its maintenance and repair obligations in the Lease, or those being assumed in this Lease Amendment.
- Air Products site to be added to the lease premises upon completion of remediation at no additional cost, and CWD to be responsible for all site improvements and for cost of compliance with all environmental inspections and reporting
- With respect to the condition of Berth 5, the parties acknowledge that the berth condition has deteriorated over time, and that SJPC will undertake periodic condition surveys and commercially reasonable repairs to continue the use of the berth by vessels, but that if the berth at any time is determined to be unusable, there will be no abatement of rent as a result.
- SJPC and CWD will continue to coordinate and expend efforts to obtain funding to repair and improve the Broadway Pier 5 Premises
- Other maintenance and repair responsibilities to remain unchanged, except that CWD assumes responsibility for all maintenance and repair of the sanitary sewer system on the terminal, which CWD accepts in its "as is' condition as of the date of this Lease Amendment. Capital investments made to upgrade or replace, but not repair and maintain, the sanitary sewer can count toward CWD's \$3 million capital investment responsibility hereunder.
