CHANGE ORDERS- (THREE)

RESOLUTION 2025-03-0041: APPROVAL OF CHANGE ORDER NO. 2 TO PS&S, LLC FOR DRAINAGE AND PAVING 551 SOUTH 2ND STREET BALZANO MARINE TERMINAL

The design services contract for drainage and paving of the property at 551 South 2nd Street at the Balzano Terminal was awarded to the low bidder, PS&S, LLC of Cherry Hill, NJ, in May 2022 in the amount of \$17,000.

The SJPC Board had previously approved Change Order Number 1 by Resolution Number 2024-04-0053

While excavating for the construction of the storm water quality garden two underground storage tanks (UST) were uncovered on February 25th and March 4th and both found to be leaking product to the surrounding soil. PS&S had been our LSRP for this site on a previous removal of an underground storage tank. We therefore requested them on an emergency basis to file a spill notification with the NJDEP and establish a removal plan.

These USTs have been pumped out, the inside cleaned, and the tanks pulled in preparation for removal from the site. The surrounding soils are to be sampled and tested to determine the amount of contamination. Soil removals are planned to be removed by others and transported to a regulated soil disposal facility once the extent of contamination is determined from the soil testing results.

This change of scope and fee is being requested for the project design firm to address filing and processing with the NJDEP, soil sampling and testing of soil at the two USTs found at the 551 South 2nd Street property, and legal removal and disposal of the two tanks and the contaminated soils.

RESOLUTION 2025-03-0042: APPROVAL OF CHANGE ORDER NO. 3 TO PAVING PLUS, LLC FOR PAVING OF 551 S 2ND STREET LOT ON THE BALZANO TERMINAL CHANGE OF DISCHARGE PIPE SIZE AND SUPPORT WORK FOR EMERGENCY UNDERGROUND STORAGE TANKS REMOVAL.

The contract for the Paving of the 551 S 2nd Street Lot on the Balzano Terminal was awarded to Paving Plus, LLC, of Glassboro, NJ, in September 2024 by Board Resolution Number 2024-09-0122 in the amount of \$ 470,470.

The scope of the work included the installation of drainage and the paving of the 551 South 2nd Street site.

The SJPC Board had previously approved two Change Orders by Resolution Numbers 2025-01-0007 and 2025-02-0024.

This additional work includes a change in drainage pipe size to the city sewer stormwater inlet from 12" to 8" due to a conflict with an underground electrical duct bank. Reducing the pipe size will enable the contractor to install the drainage pipe.

Also, during excavation two underground storage tanks (USTs) were uncovered and both found to be leaking products. NJDEP was contacted to report the USTs and spill. A separate contractor, PS&S performed the remediation work under the direction of an LSRP for the site. The tanks were pumped to remove the remaining products, cleaned and removed from the excavation. Soils samples were taken, and testing was performed to determine the extent of contamination for disposal. This change order includes support work by Paving Plus for the excavation, tanks removals, and backfilling operations.

RESOLUTION 2025-03-0043: APPROVAL OF CHANGE ORDER NO. 1 TO HARRING FIRE PROTECTION ANNUAL FIRE CODE INSPECTIONS AND REPAIRS BROADWAY FIRE PUMP BUILDING, REPAIRS RELATED TO NEW JOCKEY PUMP AND CONTROLLER.

Building fire sprinkler systems are required to be inspected yearly by NJDCA - Bureau of Fire Safety, in accordance with NFPA 25. In addition, fire extinguishers require yearly inspection and servicing in accordance with NFPA 10.

SJPC publicly advertised these services in accordance with Resolution 2023-01-0008. The firm of Harring Fire Protection, LLC, of Folsom, New Jersey was the low bidder and was awarded the contract in the amount of \$55,239.00.

The contract provided for an initial term of one (1) year with the Board's option to extend the contract for up to (2) two additional one-year terms under the same amount, terms and conditions.

By Resolution Number 2024-10-0132, the SJPC Board authorized renewal for a second year under the terms of the original contract, for the same amount, \$55,239.00.

During replacement of the jockey pump and controller at the Broadway Fire Pump Building, Harring identified other repairs in the system that are needed in order to have the new controller work properly.

These necessary repairs will cost \$16,600 as detailed in the attached proposal.

Staff is therefore requesting a change order to the Harring contract for inspections and repair in the amount of \$16,600, bringing the total contract amount to \$71,839.00.

TREASURERS REPORT

For the month of February 2025, SJPC had net income in the amount of \$474,930 which is over budget by \$447,556 for the month. Our (year-to-date) YTD net income as of February 28th is \$838,285 which is over budget by \$802,623. In February 2025 the Port had a 4.3% increase in revenue over January 2025. Cost of Goods Sold was 74% of total revenue - down 4% from January. Gross profit was 26% of total revenue - increase of 4% from January. G&A was 11% of total revenue and Net Income was 15% of total revenue. Overall additional revenue contributed to the bottom line for the month of February.

COUNSEL'S REPORT

The Counsel's Report will be discussed in closed session.

EXECUTIVE DIRECTORS REPORT

The Executive Director & CEO for the South Jersey Port Corporation reports cargo tonnage for February 2025 was 365,402 s/tons: a 4.5% decrease compared to 382,733 s/tons in February 2024. All terminals combined handled a total of 249,805 s/tons of breakbulk cargo during February 2025; showing a 49.5% increase compared to February 2024. February 2025 bulk cargo activity for all terminals was 115,597 s/tons: a 46.4% decrease from February 2024. Year to date tonnage for all terminals through February 2025 totaled 704,691 s/tons; representing an 11.6% increase compared to the same period in 2024.

CAMDEN TERMINALS ACTIVITY

Camden tonnage for February 2025 totaled 220,042 s/tons, a 24.4% decrease when compared to 290,873 s/tons in February 2024. Balzano Terminal tonnage for February 2025 was 177,919 s/tons; a 16.1% decrease compared to 212,052 s/tons in February 2024. Broadway Terminal tonnage for February 2025 at 42,123 s/tons showed a 46.6% decrease compared to 78,821 s/tons in February 2024.

Camden steel imports in February 2025 were 91,081 s/tons showing a 2.6% increase from the 88,802 s/tons in February 2024. There were 11,028 s/tons of wood products in February 2025 compared to 7,515 s/tons in February 2024: representing a 46.7% increase.

Recycled metals exports were 86,838 s/tons in February 2025 compared to 65,012 s/tons in February 2024. There was no cargo activity of Grancem in February 2025 compared to 16,695 s/tons in February 2024. February 2025 cement imports at 16,675 s/tons are 69.5% behind the 54,611 s/tons in February 2024. There was no cargo activity of Gypsum in February 2025 compared to 58,238 s/tons in February 2024. Balzano Terminal had 1 lay berth vessel day for February 2025 and Broadway Pier 5 handled 8,352 s/tons of cocoa beans and 6,068 s/tons of juice cargo.

PAULSBORO TERMINAL ACTIVITY

Paulsboro Marine Terminal handled 133,276 s/tons of steel cargo in February 2025 showing an 88.2% increase compared to February 2024. There were 11 lay berth vessel days for February 2025.

SALEM TERMINAL ACTIVITY

Export sand at 12,084 s/tons for February 2025 showing a 42.6% decrease compared to 21,051 s/tons in February 2024.

OTHER TERMINAL ACTIVITY

SJPC's marine terminals handled 29 ships in February 2025, compared with 25 in February 2024. The number of ship days (i.e., the number of days a ship is loading or unloading at its terminals) for February 2025 was 73 compared to 81 days in February 2024.

The Executive Director also updated the Board on the below topics as well:

Heart of Camden Meeting

Staff recently hosted a meeting with representatives from the Heart of Camden to discuss the recent fire at EMR. In attendance were representatives from the Governor's office, NJDEP, and SJPC Board members Roberts and MacFarlane. It was agreed that a working group should be formed consisting of representatives from the City of Camden, Camden County, SJPC, the community, and others, to maintain an ongoing dialogue with EMR and to ensure that a fire like this does not occur again in the future.

NJ EDA Wind Port Tour

Brendan Dugan and Kevin Duffy met with NJEDA staff at the Wind Port for a site visit and discussion regarding interim use opportunities related to cargo handling and/or gantry crane manufacturing.

Meeting with City of Salem NJ

Jonathan Atwood and I traveled to Salem City with Director Styles to meet with representatives of Salem City to update them on progress made on the berth expansion project at the Port and discuss the future of the Salem Port Authority.

AAPA Legislative Summit

Jonathan Atwood and I recently attended the American Association of Port Authorities (AAPA) annual Legislative Summit in Washington, D.C. It was an opportunity to meet representatives from over 80 ports from across the nation and discuss issues of importance to the maritime industry, including tariffs on steel and aluminum, grant funding, and permitting reform. Speakers included the new Chairman of the Federal Maritime Commission, the head of the National Transportation Safety Board, and senior advisor to the President, Kellyann Conway. Jonathan then joined a number of his colleagues from ports in the North Atlantic region and went to Capitol Hill to meet with key representatives in the House and Senate.

NJ Dot Rail Grant

SJPC was recently awarded \$3,393,000 through the NJDOT Rail Freight Assistance Program (RFAP) grant. The funding is to make significant improvements to the rail along Front Street at the Balzano Terminal, which recently had a Conrail train derailment.

Goldstein Property Underground Storage Tanks

While excavating for the construction of the storm water quality basin on the former Goldstein property, two underground storage tanks (UST) were uncovered on February 25th and March 4th, and both were found to be leaking product to the surrounding soil.

PS&S had been our LSRP for this site on a previous removal of an underground storage tank. We therefore requested them on an emergency basis to file a spill notification with the NJDEP and establish a removal plan.

Without delay, these USTs were pumped out, the insides cleaned, and the tanks pulled in preparation for removal from the site. The surrounding soils were sampled and tested to determine the amount of contamination. Contaminated soils were removed and transported to a regulated soil disposal facility.

Broadway Roof Leak

On Wednesday, March 5, 2025, a high wind and heavy rain event caused leaking in Warehouse D and tore off a section of roof from the southwest corner of Building Y-2. The area of roofing that will need to be replaced is approximately 4,200 square feet.

SJPC documented the damage and filed a notice of a potential claim to our insurance company. On Tuesday, March 11, the insurance adjuster inspected the damage, and we are waiting to hear back from the insurance company regarding the claim. In the meantime, we issued a request for proposals to obtain competitive quotes for the repair work.

RESOLUTION 2025-03-0045: APPROVAL TO AWARD A CONSTRUCTION CONTRACT FOR REPAIRS TO THE PIER 1 SEAWALL AT BROADWAY TERMINAL

REQUEST

Staff is requesting Board approval to award a construction contract for repairs to the Pier 1 Seawall at the Broadway Marine Terminal.

BACKGROUND

During the construction of sinkhole repair work in Pier 1, it was noted that a section of

the inshore concrete seawall had rotated caused by the advanced deterioration of supporting timber and steel piles. The area of concern was cordoned off for safety. In October of 2023, a contract for design services was awarded to GEI consultants per Board Resolution Number 2023-10-0093. A comprehensive inspection was performed, and the design prepared for the construction of the Pier 1 Seawall repair work. The NJDEP and Army Corp of Engineers permits have been received.

Pursuant to the Board Authorization: RESOLUTION 2024-06-0074 APPROVAL TO ISSUE AN INVITATION FOR BIDS - CONSTRUCTION REPAIRS TO THE PIER 1 SEAWALL AT BROADWAY MARINE TERMINAL, an Invitation for Bidders (IFB) was advertised to solicit public bids.

The IFB was posted on the SJPC website, advertised in three papers, and 23 firms were notified directly of the opportunity. A Prebid meeting was held on Thursday, December 5, 2024, with six contractors in attendance. A total of two addenda were issued, and four bids were received on Thursday, January 9, 2025, as follows:

RESOLUTION 2025-03-0046: AWARD A SERVICE CONTRACT FOR A CRANE REPAIR CONTRACTOR TO PERFORM ALL REQUIRED CRANE INSPECTIONS, PREVENTIVE MAINTENANCE, AND REPAIRS, AS NECESSARY, ON AN ON-CALL BASIS AT THE BALZANO AND BROADWAY MARINE TERMINALS

REQUEST

Staff is requesting Board Authorization to award a service contract for a Crane Repair Contractor to perform all required inspections, preventive maintenance, and repairs, as necessary at the Balzano and Broadway Marine Terminals. The contract would be on an on-call basis for a one-year period, and with options to renew for an additional two one-year periods.

BACKGROUND

The scope of work includes annual inspections, preventive maintenance, and repairs, as necessary, for the marine gantry cranes at the Balzano and Broadway Marine Terminals. It also includes support services for the two major projects currently scheduled, Slew Gear and Planetary Drive Replacement for the Kocks crane at Broadway (Resolution No 2024-03-0043), and Stay Pins and Boom Hinge Replacements at the Kocks crane at Balzano (Resolution No 2024-01-0086). The basis of award is the lowest bid for these two specific projects.

After the completion of these two projects, the contract would continue on an on-call basis for a one-year period, with options to renew for two (2) additional one-year periods subject to approval by the Board.

Pursuant to Resolution 2024-02-0032, a request for competitive bids was prepared and advertised in three newspapers and on our website. In addition, the RFB was sent directly to six prospective bidders. The pre-bid meeting was held on February 21, 2025, with three firms attending. There were four addenda issued. Bids were opened on Friday, March 14, 2025. Two bids were received as follows.

REQUEST

Staff is requesting Board approval to award a contract for construction manager / construction inspector (CM/CI) services at the Balzano and Broadway Marine Terminals on a task order basis for a two-year period.

BACKGROUND

Pursuant to the Board's Authorization: RESOLUTION 2022-06-0061 - APPROVAL TO ISSUE AN RFP TO PREQUALIFIED CONSTRUCTION MANAGERS, FOR CONSTRUCTION MANAGEMENT AND INSPECTION SERVICES AT THE CAMDEN MAINE TERMINALS, the RFP was issued soliciting proposals from the SJPC list of prequalified CM/CI firms. There are 26 firms on the prequalified list.

Proposals were received on December 12, 2024, from 6 prequalified CM/CI firms offering 18 resumes for consideration. A total of 6 candidates were interviewed and selections made based on candidate qualifications and level of experience on similar types of projects planned for construction over the next two years at the Camden Marine Terminals. REQUEST

RESOLUTION 2025-03-0049: APPROVAL TO ADVERTISE A REQUEST FOR BIDS FOR THE CONSTRUCTION OF A REPLACEMENT ROOF ON D BUILDING AT THE BROADWAY MARINE TERMINAL

REQUEST

Staff is requesting Board approval to issue a publicly advertised request for bids to construct a replacement roof on the D Building at the Broadway Marine Terminal, Camden, NJ.

BACKGROUND

The 66,000 square foot Broadway D Building warehouse was constructed around 1900.

The roof has been repaired numerous times, and the current roof material is well beyond its useful life and continues to experience chronic leaking. Frequently, heavy rain events cause leaking into the operating area of the building.

As it is no longer feasible to continuously perform temporary repairs to this deteriorated roof system, SJPC plans to replace the entire roof system and remove all the skylight structures. The drainage components of the roof system will also be replaced.

The drawings and specifications are being prepared by On-Board Engineering in accordance with Resolution 2024-12-0150.

A motion was made to approve Resolution 2025-03-0049 to publicly advertise for competitive bids to replace the roof on the D Building at the Broadway Marine Terminal.

REQUEST

Staff is requesting Board approval to renew the lease with John Lawrie Tubulars, LLC at 1535 Broadway in Camden New Jersey for a 5-year term

BACKGROUND

John Lawrie Tubulars, with a registered US office at 15551 Miller Road 1, Houston Texas 77049, has been leasing open space and buildings at 1535 Broadway in Camden since May of 2020. John Lawrie imports pipe through SJPC's port facilities in Camden, and stores and distributes pipe from the Broadway location. Their current lease with SJPC expires April 30, 2025.

Key Lease Renewal Terms:

- Lease Term: 5 years, commencing May 1, 2025, and expiring April 30, 2030
- **Premises:** Approximately 370,600 square feet (approx. 8.5 acres) at 1535 Broadway in Camden, NJ, consisting of the following:
 - 345,400 square feet of open space

- > 21,200 square feet of warehouse space
- > 4,000 square feet of garage space
- **Permitted Uses:** Premises to be used for the receipt, storage, sorting, transloading, and processing of pipe and related equipment and maintenance activities
- **Rental Fee:** Effective May 1, 2025, the tenant will pay an annual rental of \$411,396 per year/ \$34,283 per month, which includes the following:
 - > Open Area \$383,394 per year, \$31,949.50 per month
 - > Garage \$28,002 per year, \$2,333.50 per month
- Rent Escalations: Annual CPI adjustments will apply to the open area and garage space rates. CPI will be based on the CPI-U All items for Philadelphia, Camden NJ, and Wilmington DE, as published by the US Bureau of Labor Statistics
- Warehouse Fee: Until the landlord is notified in writing by the tenant that it intends to use the warehouse located on the premises, the lease shall not include a lease of or use of the warehouse by the tenant. Until such time that the tenant notifies the landlord of its intent to use the warehouse, SJPC may use or lease the warehouse to other tenants. If the tenant commences use of the warehouse, they shall pay an annual rental for the warehouse space as follows:
 - **Lease Year 1:** \$98,328 per year, \$8,194 per month
 - ➤ Lease Years 2-5: Year 1 lease rates will escalate according to the same CPI calculation that applies to the open area and garage sites
