#### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Must be fully qualified to perform a wide variety of automotive repair work, including trouble shooting, tune ups, replacement of engine parts and equipment parts and making necessary adjustments, the ability to weld, torch and burn metal, work independently.
- The work is principally on forklift trucks, front end loaders and other mobile and stationary equipment.
- Must be able to use automotive test equipment, hand tools such as screwdrivers, wrenches and pliers and machines such as drill presses, grinders, and presses.
- Must be able to read, write legibly, understand, and apply instruction manuals for various equipment, must be able to keep maintenance records.
- Qualified applicants must be able to provide their own tools and toolbox.
- Must have firsthand experience working with Electric Vehicles (EVs), including diagnostics, maintenance, or system integration.
- Proven experience with hydraulic systems, including troubleshooting, repair, and installation.

#### MINIMUM QUALIFICATIONS:

- Minimum of 5 years of relevant experience required.
- The New Jersey First Act, effective September 1, 2011, established residency requirements for all public employees. The applicant shall have their principal residence in the State of New Jersey.
- Must possess a Federal Transportation Worker Identification Credential issued by the Transportation Security Administration.
- Must possess a valid, unrevoked, and unsuspended driver's license.

**EDUCATION AND EXPERIENCE:** High school graduates with a minimum of 5 years of related experience.

**TESTING:** All applicants for this job opening must be willing to take a written test to demonstrate qualification in one or all the above areas of specialization. A practical test in these areas will also be required. Management will judge whether an applicant is qualified for this position. Certain portions of the examination procedure may be waived by Management based on an applicant's experience in performing this level of work.

**COMPETENCY:** To perform the job successfully, an individual must be willing to take a written test to demonstrate qualifications in one or all the above areas of specialization. A practical test in these areas will be required.

#### WORK ENVIRONMENT:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Work is performed from the standing position with frequent bending, stooping, lifting, stretching, crawling, squatting, or kneeling on one or both knees. Workers are in constant contact with grease, oil, and dirt. Work is performed whenever or wherever the requirement exists and is performed under prevailing weather conditions. While performing the duties of this Job, the employee is occasionally exposed to wet and/or humid conditions and moving mechanical parts. The noise level in the work environment is usually moderate.


